II. ELIGIBILITY TO APPEAR :

Candidates who have passed ITI and Bridge course practical examinations are eligible. The candidates who have compartmentally passed or appearing ITI and Bridge course practical examinations are also eligible to apply. However, they must have passed in all the subjects before seeking admission.

III. Syllabus: Diploma I Year Mathematics, Physics and Chemistry prescribed by SBTET AP, Vijayawada

IV. MODE OF EXAMINATIONS:

Examination for ITI Lateral entry into Diploma Course comprise the following.

Theory examination

- a) Mathematics 100 marks
- b) Physics 50 marks
- c) Chemistry 50 marks

VI. HOW TO APPLY :

The candidates' willing to appear for the above examinations has to file the online application through https://sbtet.ap.gov.in/APSBTET portal, by uploading his/her photo and signature. The candidate can make fee payment through payment gateway (i.e Debit card/Credit Card / Net Banking). Color Photos are only accepted. Black and White photos and photos taken with wearing cap/cooling glasses as the purpose of clear identity gets defeated.

VII. Examination Fee Details:

- 1. The examination fee is **Rs. 400/-**
- 2. Last date for fee payment **03-11-2021.**

- 4. Examination fee must be paid through payment gateway ie. Debit Card/Credit Card/Net Banking.
- 5. Fee once paid will not be refunded or adjusted under any circumstances.

VIII. HALL TICKETS :

The Hall Tickets will be placed in <u>https://sbtet.ap.gov.in/APSBTET/</u> portal 3 days before the examination. The candidate can get the printout of the Hall Tickets and must get it attested by a Gazetted Officer before appearing for the examination.

IX. RESULTS OF EXAMINATIONS:

The candidate has to secure minimum 35% of marks in each subject i.e in Mathematics, Physics & Chemistry

The results will be declared by the SBTET AP and will be kept in the same website.
